The information provided hereafter is also based on Recommendation no. 2/2001 of the European Data Protection Supervisor for the protection of personal data, adopted on 17th May 2001 pursuant to art. 29 of Directive no. 95/46/EC, in particular in regards to the collection of personal data on the internet, and aims to identify the minimum measures that must be implemented to guarantee the integrity and lawfulness of said practices for interested parties (in the application of articles 6, 7, 10 and 11 of Directive 95/46/EC).

WEBSITE BROWSING

Data handling

Data handling connected to web services offered by this website is carried out at the offices of the data controller company by employees, collaborators or partners assigned to data handling, or by any parties responsible for occasional maintenance works. No data obtained through web services is communicated or disclosed. Personal data provided by users that send requests for services is used for the sole purpose of fulfilling the service requested and is not disclosed to third parties, unless said disclosure is imposed by legal obligations or strictly necessary to fulfil the request.

Type of data

The computer systems and software procedures used to operate this website collect certain personal data during their normal use, the transmission of which is implicit in the use of internet communication protocols.

This data is not collected for the purpose of being associated with identified parties, however by its nature, through its processing and association with data held by third parties, it may allow the identification of users.

This category of data includes IP addresses or computer domain names used by users that connect to the site, URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used to submit the request to the server, the size of the response file, the numeric code indicating the status of the response provided by the server (successful, error, etc.) and other parameters relative to the user's operating system and operating environment.

This data is used for the sole purpose of obtaining anonymous statistical data on the use of the site and to monitor its correct operation. Said data is cancelled immediately after its processing.

The data in question may be used to determine liability in the event of IT crimes causing damage to our website: except in this case, data on web contacts is not stored for more than seven days.

Data voluntarily provided by the user

The optional, explicit and voluntary sending of emails to the addresses indicated in this site, by its nature involves the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data inserted in the message. Synthetic informative specifications are reported in the pages of the site dedicated to special services on request.

Cookies

The function of cookies is to facilitate the analysis of web traffic or record when a specific site is visited. They allow web applications to send information to individual users. No personal user data is purposefully acquired by the site. Cookies are not used to transmit information of a personal nature, except in those areas of the site where explicit authentication is required.

Faculty to provide data

Except when specified for browsing data, the user is free to provide their personal data to request the sending of informative material or request other types of services offered by the Company. Failure to provide said data may make it impossible to obtain the requested service.
